As mentioned earlier, the primary purpose of the study of history is to understand the past, how it influenced and shaped the present, and how it can be used to predict the future. The presenters of this study found that the past has the opportunity to tell the presenters how the world is to move to create freedom in a peaceful manner in their cities in the short and distant future. Through the historical perspective, students can learn to predict and analyze their future. The process of this research is to teach students to analyze their past in order to predict their future. The clashes continued in various parts of the South Caucasus through 1905 and 1906. "Witnesses" gave conflicting accounts about who attacked whom first in particular clashes, which was reported in the media or conveyed in rumors, and led to increased anxiety and mistrust between Armenians and Azeris. Between 3,100 and 10,000 people are believed to have died during this period.²
